PRIVACY POLICY

Lokkout.com Privacy Policy

Lokkout.com is owned and operated by Lokkout, INC. This Privacy Policy describes how information about you is collected, used, and disclosed by Lokkout, INC and our parents, subsidiaries and affiliates (collectively, "Lokkout," "we" or "us") when you access or use our website (collectively, the "Service"), or otherwise interact with us in connection with Lokkout.com. Please note that we may have different privacy policies with respect to certain parents, subsidiaries, affiliates, programs, or activities, and in those cases, this Privacy Policy will not apply.

Children under the age of 13

Lokkout.com is not directed to, and does not knowingly collect personal identifiable information from, children under the age of thirteen (13). If it is determined that such information has been inadvertently collected on anyone under the age of thirteen (13), we shall immediately take the necessary steps to ensure that such information is deleted from our system's database, or in the alternative, that verifiable parental consent is obtained for the use and storage of such information. Users between the age of 13 and 18 must receive parental consent to use our website and services.

INFORMATION COLLECTION

Information You Provide to Us

Lokkout.com collects information from you when you choose to provide it to us. This may include when you request information from us, sign up for our newsletters or email lists, access or use our Service, make a purchase, participate in our contests, promotions, sweepstakes, surveys, or interviews, request support, or otherwise interact with us.

The information we collect may include your name, address, email address, telephone number, photos, videos, payment information, and any other information you choose to provide. You may also be required to provide certain information to access certain portions of the Service.

Information We Automatically Collect

We may use cookies, web beacons, pixel tags, log files, or other technologies to automatically collect certain information when you use our Service. For example, we may automatically collect information such as your browser type, device type and operating system, unique device identifier, software version, IP address, and the domain name from which you accessed the Service. We also may collect information about your use of the Service including the date and time you access the Service, the areas or pages of

- As necessary if we believe that there has been a violation of the Lokkout.com Terms of Service;
- To respond to judicial process or provide information to law enforcement or regulatory agencies or in connection with an investigation on matters related to public safety, as permitted by law, or otherwise as required by law;
- In connection with any merger, sale of assets, financing, bankruptcy, or reorganization of our business; and
- With your consent.

Further, Lokkout may share aggregated or anonymous information which cannot reasonably be used to identify you.

Security

Lokkout takes precautions to protect your information. When you submit personal identifiable information via the website, your information is protected both online and offline. Wherever we collect sensitive information (e.g. credit card information), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a lock icon in the address bar and looking for "https" at the beginning of the address of the webpage.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only those employees/contractors who need the information to perform a specific job function (for example, billing or customer service) are granted access to personally identifiable information. The computers and servers in which we store personally identifiable information are kept in a secure environment. This is all done to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

Lokkout also uses Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information.
